



License Agreement for Font Software (Pre-Made Premium 'Ultra' Fonts – Commercial Use Purchase)

This Agreement, in conjunction with the receipt that accompanies each purchase from Quantum Enterprises, constitutes the complete agreement between you and Quantum Enterprises.

The agreement covers TrueType font (TTF) and single line font (TTF and SVG) formats of each font.

1. Allowed uses

You may use the licensed fonts to create images on any surface such as computer screens, paper, web pages, photographs, movie credits, printed material, T-shirts, and other surfaces where the image is a fixed size.

You may use the licensed fonts to create EPS files or other scalable drawings provided that such files are only used by the household or company licensing the font.

2. Number of users

Quantum Enterprises grants the licensee the non-exclusive, non-transferable right to simultaneously use or store the font on a maximum of five (5) computers (workstations) at one single geographical location stipulated by the licensee.

In the event that extensions to the above-mentioned restriction become necessary, the licensee has to purchase an extended license.

3. Third parties

You may provide the font to a graphic designer, printer or other service bureau that is working on your behalf only if they agree to use the font exclusively for your work, agree to the terms of this license, and retain no copies of the font on completion of the work.

You may not provide the font or make it accessible to any other third parties.

4. Embedding

You may embed the licensed fonts into any document you send to third parties. Such documents may be viewed and printed (but not edited) by the recipients.

You may not under any circumstances embed the licensed fonts into software or hardware products in which the fonts will be used by the purchasers of such products, without written permission from Quantum Enterprises and an authorised modification to the license agreement. 5. Modifications

You may import characters from the font as graphical objects into a drawing program and modify such graphical objects.

You may not modify, adapt, translate, reverse engineer, decompile, disassemble, or create derivative works based on the licensed font itself without Quantum Enterprises' prior written consent.

6. Copyright

The font and the accompanying materials are copyrighted and contain proprietary information and trade secrets belonging to Quantum Enterprises. Unauthorized copying of the Product even if modified, merged, or included with other software, or of the written materials, is expressly forbidden. You may be held legally responsible for any infringement of Quantum Enterprises' intellectual property rights that is caused or encouraged by your failure to abide by the terms of this Agreement.

7. Termination

This Agreement is effective until terminated. This Agreement will terminate automatically without

notice from Quantum Enterprises if you fail to comply with any provision contained herein. Upon termination, you must destroy the written materials, the Product, and all copies of them, in part and in whole, including modified copies, if any.

8. Disclaimer and Limited Warranty

Quantum Enterprises warrants the Product to be free from defects in materials and workmanship under normal use for a period of ninety (90) days from the date of delivery as shown on your receipt. Quantum Enterprises' entire liability and your exclusive remedy as to a defective product shall be, at Quantum Enterprises' option, either return of purchase price or replacement of any such product that is returned to Quantum Enterprises with a copy of the invoice. Quantum Enterprises shall have no responsibility to replace the product or refund the purchase price if failure results from accident, abuse or misapplication, or if any product is lost or damaged due to theft, fire, or negligence. Any replacement product will be warranted for ninety (90) days.
